Hull Food Action Plan - 2025-2028

Introduction

When Hull Food Partnership developed the first <u>Hull Food Action Plan 2019-2021</u>, it was in support of Hull's successful <u>Sustainable Food Places Bronza</u> Award application in 2019.

At the time it was launched, the city and the UK as a whole was in a very different position, investment in the <u>UK City of Culture in 2017</u> had unleashed significant funding into Hull's leisure and cultural sectors, with increased opportunities for out of home food businesses and retailers to capitalise on an increased influx of visitors and tourists, and capital improvements to the city centre making Hull a genuine prospect for economic success and resident's confidence for the first time in half a century.

Despite this, Hull faced significant challenges in relation to food insecurity and childhood overweight and obesity, with the local authority sitting in 4th place on the <u>English Indices of Multiple Deprivation</u>. These were addressed in the first Hull Food Action Plan, with ambitions to bring communities and anchor institutions together to create a place that worked towards developing a coherent approach to tackle eight key areas in relation to food:

- A better food culture
- Increase food skills and knowledge
- Promote healthy food
- Work towards food equality
- Encourage a sustainable food economy
- Develop sustainable supply chains
- Increase food production
- Reduce ecological impact

Always positioned as 'starting the journey creating a culture of sustainable, healthy, equitable and affordable food for everyone in the city', the opportunity to put the first Action Plan into practise was catastrophically halted by the global Covid-19 pandemic in 2020, followed by the challenges of the ongoing cost of living crisis that continue to this day, initiated and perpetuated by the national Government's adherence to austerity policies. Within this context, the increasingly erratic climate conditions that impact on both local and global food supply chains, and the creation of two different national food strategies, which have yet to see significant policy drivers come into force to positively change citizen's diets, we have taken the decision to use this new action plan to reframe how we approach food systems change in Hull.

We also want to use the <u>Three Horizons tool</u> as advocated by <u>Fix Our Food</u> to understand our current food system and how systems transformation can be achieved locally through new interventions and stakeholder engagement.

An iterative, 'test and learn' approach means that we have used the <u>Sustainable Food Places Six Key Issues</u> as the framework around which we build the structure of both the Hull Food Strategy and Action Plan, any future changes to these will be reflected in our work as we seek to align with best practice happening nationally as well as at place.

A focus shift has been necessary in that although the Action Plan continues actions around promotion and awareness, it also catalyses strategic action within policies through the convening of Task and Finish Groups who cover each of the Six Key Issues. Members of the Task and Finish Groups are drawn from across statutory bodies, VCSE and private sector organisations, and are expected to be able drive action or have the ability to make sure things are escalated within their own organisation to achieve action. Chairs of the Task and Finish Groups form the Hull Food Partnership Steering Group and ensure that actions are implemented at a strategic level so that food is threaded through the other complementary Plans and Strategies that impact on the lives and wellbeing of Hull's residents.

Although the <u>'Well Fed?' Hull Food Strategy</u> covers the five years from 2024-2029, the revised Hull Food Action Plan spans three years from 2025-2028 to take account of the constant flux the current food system is in, and the monitoring, consultation and planning that will be required to develop the next iteration of the Hull Food Strategy from 2030 onwards.

Hull Food Strategy / Action Plan Six Key Pillars / Issues

The Hull Food Action Plan is built around the six key pillars of the Hull Food Strategy which are as follows:

- 1: Strategic and collaborative approach to good food governance and action: Helping local organisations and people to work together to support sustainable and affordable food in Hull.
- 2: Building public awareness, active food citizenship and local good food movement: Local people working together, learning, growing, and cooking and eating in an informed way, using their power to change things for the better.
- **3: Tackling food poverty and diet related ill-health and increasing access to affordable healthy food:** Affordable and nourishing food ensuring that everyone can easily get and can afford nutritious, tasty food
- **4: Creating a vibrant, prosperous and diverse sustainable food economy:** Local organisations and people buy from local food businesses first, where possible.
- **5: Transforming catering and procurement and revitalising local and sustainable food supply chains:** A thriving and robust local food sector from field to plate, with fairly-paid staff.
- **6: Tackling the climate and nature emergency through sustainable food and farming and an end to food waste:** All local organisations and people help to tackle climate change and benefit nature by making ethical, informed food choices.
